The group continues to play an active role in facilitating deeper intermediation in the Malaysian financial sector by providing liquidity, capital and risk management solutions.

Cagamas also offers a wider

source and tenor of funding for financial institutions.

For the financial year ended 2015, Cagamas Bhd (CB), Cagamas MBS Bhd (CMBS) and Cagamas SRP Bhd (CSRP), remained very strong, achieving a higher pre-tax profit of RM558.3 million against RM546.5 million in 2014, arising from higher profit contributions from both CB and CMBS.

The group's core capital ratios and risk weighted capital ratios stood at 37.3 per cent and 37.2 per cent, respectively. — Bernama
